#### Overall Observations:

Man power is not available sufficiently. Well-furnished laboratories are available. Good infrastructure and state-of-art laboratories are available. Retention period of department is low, due to faculty left the institute recently. The department was established in the academic year 2020-21 with an annual intake of 60 students. In the year 2021-22, such intake was increased to 120. Audit team observed that, course allocation, time tables framing and other academic activities of the department is done at Computer Science and Engineering (CSE) department. As per the Principal orders, Artificial Intelligence and Data Science (AIDS) department is de-centralized and appointed a designated Head of the department. Unfortunately, these two departments are working together. This attempt makes a problem in future in terms of document preparations such as course allocation, course files, workload, fixation of course

outcome targets, assessment, feedback analysis, departmental meetings and other academic and administrative activities of the department etc.,

## Suggestion:

Department has to maintain standards to make to develop good system related to academics and to prepare quality files to meet the requirements of National Board of Accreditation (NBA), National Assessment and Accreditation Council (NAAC) and University Grant Commission (UGC) Extension of Autonomy, Ranking bodies and other statutory bodies.
