## ORDER:

- 1. The "Annamacharya Institute of Technology & Science, New Boyanapalli, Rajampet, Kadapa Dist." was given Permanent affiliation for running certain Degree courses vide Procs.(1a) read above, and temporary affiliation to other courses during the academic year 2010-11 vide Procs.(1b) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2014-15 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for the grant of **Permanent Affiliation** from the academic year 2014-15 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The Standing Committee for Affiliation has verified the Fact Finding Committee reports and other documents pertaining to the college and made recommendations for **Permanent Affiliation** from the academic year 2014-15.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report.

- 1. The Department of ECE runs 4 M.Tech. programmes (three in 1<sup>st</sup> shift and one in 2<sup>nd</sup> shift). However, the department has no qualified Professor or Associate Professor.
- 2. Total intake of I B.Tech being 780 students, a minimum of only 13 lab sessions is required at the rate of 60 students per session. However, a maximum of only 12 lab sessions are possible in a week. Therefore, sufficient equipment and space should be provided in Physics lab, Chemistry lab, Mechanical workshop and IT workshop.

- 3. CE, EEE, ECE branches and MBA programme require additional faculty to meet the student/teacher ratio as per norms
- 4. In order to maintain computer to student ratio for PG programmes, the college has to procure 350 additional computer systems
- 5. Conduct of M.Tech labs in ECE department is poor. The learning outcome of students from the laboratory experiments is far below the standards of M.Tech particularly in the case of VLSI system design and DECS specializations.
- 6. Laboratories for ensuing III B. Tech of CE branch should be established
- 7. Principal's appointment is not ratified by the University. Less that 33% of the appointments of the teaching faculty are ratified (54/168 are only ratified)
- 8. ECE branch requires computer systems with sufficient RAM to run MATLAB software in Simulation and Signal Processing Labs. It is observed that the old systems present in the above labs do not have sufficient RAM.
- 9. The following points are given based on the interactive sessions held with students and faculty:
  - a) Amenities like drinking water, toilets and street lights in the campus need improvementb) Campus placements are to be improved
- 10. Teacher to Student Ratio is to be improved to 1:12 from MBA 1:60; MCA 1:26; for UG to 1:15 from EEE 1:31; ME 1:19; ECE 1:28; CSE 1:21; IT 1:20; CE 1:60
- 11. The following branches faculty are with B.Tech. qualification only EEE 3, ME 8, ECE 5, CSE 6, IT 3, CE 4, HSS 18 -> No M.Phil/Ph.D/NET/SLET
- 3. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Permanent Affiliation** to "Annamacharya Institute of Technology & Science, New Boyanapalli, Rajampet, Kadapa Dist" sponsored by "Annamacharya Educational Trust, 2-2-25/P/7/1, DD Colony, Bagh Amberpet, Hyderabad" to offer Degree Course in the following disciplines with the intake shown against each for a period of <u>3 (Three)</u> years from the Academic Year 2014-2015 as detailed below:

The Permanent/Temporary affiliation shall be subject to the following conditions:

- 1. The management shall follow the norms of AICTE and the rules of the affiliation of JNT University Anantapur in all aspects.
- 2. The management shall follow the Academic Regulations and examination schedule of JNT University Anantapur.
- 3. Anti-ragging measures to be taken strictly in accordance with UGC regulations on curbing the menance of ragging in Higher Educational Institutions, 2009 (F.1-16/2007 (CPP-II))
- 4. Regular meetings of College Academic Committee and Governing Body shall be conducted.
