Research & Development Cell - Guidelines for Financial assistance Claims and Sub:-Data Submission - Reg.

All the Deans, Heads of the Departments and Functional Heads of various Cells / Bodies / Sections are requested to follow the following guidelines connected with Research and Development Cell activities.

- 1. All the departmental coordinators are requested to submit their respective department Journal Publications / Patents / Books / Book Chapters etc., and Symposia / Seminars / Workshops etc., conducted as well as attended once in an every month through provided GoogleForm by R&D Cell.
- 2. All the Departmental coordinators are requested to submit relevant information / documents related to students paper publications / conference / workshops attended etc.,
- 3. All the faculty members are requested to submit any claim Forms / proposals to the principal through R&D Cell.
- 4. All the faculty members are requested to submit one hard copy of their funded project proposals and other relevant data / information, if any one submitted / sanctioned to / from government / nongovernment organizations to R&D cell.
- 5. All the members are requested to submit a xerox copy of No objection certificate for PhD registration to R&D Cell, if the same is obtained from the Principal Office. It is the individual member responsibility to submit the same to R& D cell. (Note: Ph.D. pursuing data is to be updated in the Institute website)
- 6. Henceforth, the claims are processed as follows:
  - a. All the members are requested to submit the claim forms to the Coordinator, R&D Cell
  - Such documents are verified by Coordinator, R&D cell and forwarded to the Dean, R&D Cell
  - c. Dean, R&D cell recommends the relevant documents and forwards to the Principal for final approval / decision
  - d. Principal approves the proposal and forwards it to finance section for funds release. (\*Note: Your claim file moves from the Coordinator to Finance section without faculty pursuance / interventions)

7. All the departmental coordinators are requested to submit their respective departmental (Students and Davaly PRINCIPAL Faculty) data before 5th of every month without fail.
