Further, council stated that it is a good initiative by the institute to offer B.Tech Minors/ Honors program wherein the students earn extra 20 credits (over and above 160 credits) through offline/online courses and learning multidisciplinary concepts.



13.14 To consider the credits transfer from SWAYAM Platform / MOOCs as per UGC (Credit Framework for Online Learning courses through SWAYAM) Regulations, 2021 as adopted by AICTE on the similar pattern

 Principal presented University Grants Commission (Credit Framework for Online Learning Courses through SWAYAM) regulations 2021, Gazette published on March 25th, 2021.

University Grants Commission has permitted up to 40% of the total courses being offered by higher educational institution in a particular programme in a semester through the online learning courses offered though SWAYAM platform. And NEP-2020 is also emphasizing it and promoting online learning courses through study webs of active learning as per (Credit framework for online learning courses though webs of active learning for young aspiring minds), Regulations 2021.

Further, the principal brought to the notice of council members is that, the UGC issued a Public Notice dated 03.06.2022 (with file no : D.O.F No- 1-8/2017 (SWAYAM)) stating that the SWAYAM platform is an indigenous platform of the GOI which hosts MOOCs (Massive Open Online Courses) courses to enable students to virtually attend the courses taught by the best faculty; access high quality reading resources; participate in discussion forums; take tests and earn academic credits up to 40% of total courses offered in a programme in a semester through the online courses offered on SWAYAM platform. It is aimed at benefiting lifelong learners, students, teachers, researchers, to use multimedia on anytime, anywhere basis for acquiring knowledge and skills.

After thorough discussions and deliberations, the Council noted and approved.

13.15 To consider and approve the 2015, 2016, 2017 and 2018 course completed students for internal marks improvement

• Principal informed the Academic council members that the following number of students under R15 and R17 regulations are seeking permission to re-appear for the internal examination of any four courses after their course work is completed.

After thorough discussions and deliberations, the Council has permitted 116 students to re-appear for the internal examinations after paying prescribed Fee. However, the students have to attend the course work. Further, students are informed that the internal marks secured in the above subjects earlier will be cancelled. Students those who have applied for the improvement of internal examination earlier, not permitted.

13.16 To consider and approve the proposal to introduce double valuation system for UG courses

- Principal started the discussion about double valuation system for UG Courses. After thorough discussion, it is inferred that the double valuation system is not viable and hence decided that double valuation system is a futile one.
- 13.17 To consider and approve the amendment on Theory of Machines course of II B.Tech II Semester Mechanical Engineering under R20 Regulations
 - After thorough discussions and deliberations, the Council noted and accepted.
- 13.18 To consider and approve the Question Bank for conducting supplementary examinations for old regulations students (i.e., R15 & R17)
 - After thorough discussions and deliberations, the Council resolved to approve the usage of unused Question bank for supplementary exams of R15 & R17 batches.
- 13.19 Appraisal on grant of accreditation for B.Tech Programme- EEE, ECE and CSE under Tier-1 by NBA New Delhi for a period of 3 years w.e.f. 01.07.2021 and valid up to 30.06.2024
 - The Academic Council noted the status of accreditation of three Undergraduate programs.
- 13.20 Discussion on conducting supplementary for the IV B.Tech students who have got placements but have one backlog apart from advanced supplementary examination
 - The council approved to permit the students (who have one backlog) to attend one more supplementary examination for MOOC courses. Amendment is applicable for the academic year 2021-22 only.
